# Regulations for a mass event "Beer hall"

Pursuant to Art. 6 (3) of the Act of 20 March 2009 on mass event safety, these Regulations for mass events [hereinafter referred to as the Regulations] are hereby introduced and made available.

## § 1

## Event organiser

The organiser of the "KGHM CENTRAL BEER HALL", hereinafter also referred to as the "Event" is KGHM Polska Miedź S.A. with its registered office in Lubin, M. Skłodowskiej-Curie 48 Street, 59-301 Lubin, KGHM Polska Miedź S.A. Department ZG "Rudna" in Polkowice, , 59 – 100 Polkowice, tel. 725 445 562.

## § 2

#### Event venue

These Regulations apply at the venue of the Event, which will be held on 29 November 2024 at the Sports Hall, Wita Stwosza 1 Street, 67 - 200 Głogów, between  $6^{pm}$  and  $9^{pm}$ .

## § 3

## Conditions for participation'

- **1.** Invited persons may take part in the event if they present an appropriate personal invitation at the entrance to the venue and are on the guest list.
- **2.** Acceptance of the invitation and arrival at the Event constitutes acceptance of and commitment to these Regulations.

## § 4

## Security and information service

- **1.** Security of the Event's participants and its course is ensured by the security service and information service appointed by the Organiser, properly marked with badges "Security Service" or "Information Service", placed in a visible place and equipped with reflective waistcoats with appropriate markings on the waistcoat, i.e. "Security Service" or "Information Service".
- **2.** The security service has the right to ask the participant to present a document confirming his/her identity and to check his/her right to stay at the Event's venue.
- **3.** The security service is entitled to check persons using technical means in order to determine whether they pose a security risk due to alcohol or drugs consumption, or due to carrying weapons or dangerous objects, as well as to measure the temperature of participants at the entrance to the Event.
- **4.** The security services have the right to check the identity of a participant of the Event in order to establish, in particular, whether he/she has not been banned from entering the Mass Event or to search the contents of his/her bag and clothes in case there is a suspicion that the participant brings weapons or other dangerous objects (tools), explosives and pyrotechnic products, alcoholic beverages, narcotics or psychotropic substances to the Event. A person's identity is established on the basis of the following document: identity card or temporary identity card, document confirming

identity of a foreigner, passport, other documents with a photograph and address of the person being identified.

**5.** In cases specified in the Act on Security of Mass Events, the security services are entitled to apprehend, in order to immediately hand over to the Police, persons posing a threat to the goods entrusted to security and persons committing criminal acts.

## § 5

## **Detailed provisions**

- **1.** Participants of the Event are obliged to respect the requests and orders of the Event's staff, connected with the correct conducting of the Event and complying with the provisions of these Regulations, ensuring order and safety.
- **2.** The Organiser and persons operating the Event may request that the participant or any other person who violates the provisions of these Regulations, the law, prevents or disturbs the proceedings of the Event or poses a threat to order or safety, leave the Event.
- **3.** The Organiser of Event is entitled to interrupt or cancel the Event in case there is a direct threat to the life or health of persons or to the property, or if the proceedings of the Event violate the regulations in force or the provisions of the Regulations to the extent which makes its undisturbed course impossible, if the participants do not comply with the Organiser's orders, as well as in case of other situations/events which cannot be predicted in advance and which cannot be prevented.
- **4.** A Participant of the Event agrees to leave the venue after its scheduled end, or in the event of its interruption/dissolution by the Organiser or other authorised bodies.
- **5.** Each participant of the Event should carry an identity card.
- **6.** During the Event, there is a deposit point at the information desk.
- **7.** Items posing a safety risk to other participants (possession of which outside the venue is not forbidden) or which it is forbidden to bring into the venue should be handed in to the depository until the end of the Event.
- **8.** The Organiser reserves the right not to allow into the Event's venue or to expel from the Event's venue a person who does not allow their clothes or luggage to be inspected by a security service employee or who does not present an identity card.
- **9.** The Event Organiser reserves the right to cancel the Event for reasons beyond its control, especially in case of changes in the law related to restrictions, orders and prohibitions connected with the state of the epidemic threat.
- **10.** The Organiser shall not be held responsible if the Event is cancelled or rescheduled due to reasons resulting from these Regulations.
- **11.** The Organiser shall not be liable for damage caused to a participant by the actions of third parties, including another participant.
- **12.** The Organiser reserves the right to change the programme of the Event for important reasons beyond the Organiser's control, in particular in case of changes to the law concerning sanitary requirements, restrictions, orders and prohibitions connected with the state of the epidemic threat, the need to ensure safety, protection of life or health of people or property or the need to ensure undisturbed and comfortable course of the Event for the participants.

## Rules of conduct for persons attending the Event

- 1. It is forbidden to bring into the Event venue:
- a) alcoholic beverages, drugs and narcotics,
- b) all types of firearms, gas weapons, sharp instruments, knives, clubs, etc.
- c) objects that can be used as weapons or projectiles,
- d) containers for spraying gas, corrosive or dye substances,
- e) glass containers such as bottles, glasses, containers for liquids or foodstuffs made of hard material, and plastic bottles,
- f) fireworks, glowing balls and other pyrotechnic objects.
- (Persons in possession of items and means prohibited by common law will be apprehended and immediately handed over to the Police).
- **2.** It is forbidden to go out, to pass through or to climb structures and devices not intended for public use, especially fences, enclosures, lighting devices, platforms, banners, masts, roofs, etc.
- **3.** It is forbidden to enter or stay outside the designated venue where the Event takes place, including the prohibition to enter fenced areas, official rooms, closed to the participants of the Event.
- **4.** Moreover, it is forbidden to:
- a) throwing all kinds of objects,
- b) lighting fires, fireworks or glowing balls, other pyrotechnic objects,
- c) covering the face or otherwise disguising it to prevent identification by the Police and security services,
- d) littering the area, damaging the property of the Organiser and other participants of the Event.
- **5.** Everyone staying at the Event's venue is obliged to behave in a way that does not harm or endanger others, in a way that does not endanger the safety of others or property.
- **6.** Participants of the Event are obliged to comply with the regulations and orders of the Police, Fire Brigade and security service.
- 7. All entrances and exits and escape routes must be kept clear.
- **8.** In the event of an evacuation, remain calm and strictly follow the instructions of the emergency services.
- **9.** The security services have the right to remove disorderly persons from the Event's venue. An employee of the security service calls a person who is not authorised to be at a mass Event or who disturbs the order to leave the mass Event, informing such a person of the reasons for the order.
- **10.** Accidents, damages, dangerous situations, danger to life, health or property must be reported immediately to the Organiser security or information services.
- **11.** Hand disinfection is mandatory at the time of entry and during the Event.
- **12.** The Organiser reserves the right to remove from the Event Venue by the security services any person, who does not comply with the rules and regulations or whose presence at the Event Venue is or could be a source of danger to others.

## § 7

## Responsibility

1. Persons failing to comply with the order or summons issued under the Act on Security of Mass Events by the security services or information services at the time and place of the mass event, in accordance with the Law on Security of Mass Events, shall be subject to a penalty of restriction of liberty or a fine.

- **2.** The Participant is responsible for the damage he/she causes and undertakes to pay it to the Organiser within fourteen days of the Event.
- **3.** Persons violating the rules of safety and order at the Event Venue will be held criminally or civilly liable.

## § 8

## Final provisions

- 1. The course of the Event may be photographed, filmed, recorded by the Organiser or other appointed third parties and replayed, including via video screens and other devices being image or sound carriers.
- **2.** By taking part in the Event, the Participant agrees to the free use of their image by recording and disseminating it, within the meaning of the Act on Copyright and Related Rights, by the Organiser or other persons acting on its behalf, in particular on film, photographs, websites, and promotional materials.
- **3.** The Organiser is not responsible for the objects left in the Event's venue and for the vehicles and objects left in the vehicles in the car park outside the Event's venue.
- **4.** Participants are obliged to observe the law regulations in force on the day of the Event in the event of establishing specific restrictions, orders and prohibitions, including those related to sanitary requirements and the state of epidemic threat.
- **5.** Notwithstanding the provisions of these Regulations, the Organiser's services shall refuse a person entry to the mass Event in cases specified in Article 22(1) of the Act on Security of Mass Events.
- **6.** Complaints and requests shall be addressed to the Organiser or the Security Manager of the mass event (information desk located at the entrance to the Sports Hall).

- **8.** The Organiser reserves the right to change the provisions of these Regulations in the event of changes to the law relating to restrictions, orders and prohibitions connected with the state of the epidemic threat.
